**Criteria and Instructions:**

The Dr. Robert S. Haeger Scholarship Fund will provide scholarship money for graduating seniors who will attend an accredited public or private two-year college, vocational-technical institute or four-year college during the school year. The award recipients will come from current or prior families of patients of Dr. Robert Haeger. The funds will be paid directly to the schools upon presentation of the tuition bill.

The following criteria will be the basis for selection:

- 1) An overall grade point average of 3.0 during the 9th-12th grades
- 2) School and community activity involvement
- 3) Evidence of abilities, potential, motivation and desire to succeed
- 4) Financial need

Students must submit the following with the completed application form:

- 1) Official copy of high school transcript
- 2) ACT and/or SAT scores
- 3) Completed questionnaire (limited to two typed pages)
